situate, lying and being on the west side of Wait Street, just south of the Laurens Road, near the City of Greenville, being known and designated as Lot No. 14 of Block B on plat of East Highlands Estate made by Dalton & Neves, Engineers, April 1940 and recorded in the R. M. C. Office for Greenville County, S.C. in Plat Book K, at pages 35 and 36, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the west side of Wait Street, joint front corner of Lots 14 and 15 of Block B, and running thence with the line of Lot 15, N. 75-41 W. 140.8 feet to an iron pin on the northeast side of a 5 foot strip reserved for utilities; thence with the northeast side of said strip S 32-23 E. 64.7 feet to an iron pin; thence continuing with the northeast edge of said strip S. 49-52 E. 104.4 feet to an iron pin on the west side of Wait Street; thence with the west side of Wait Street N. 14-19 E. 90 feet to the beginning corner.
