EXECUTOR'S TITLE TO REAL ESTATE

THIS INDENTURE, MADE this 20th day of October in the year of our Lord one thousand nine hundred and Forty-four between C. T. Reid, as Executor of the last Will and Testament of T. H. Reid, late of Campobello in the County of Spartanburg and State of South Carolina, deceased, of the first part, and G. B. Williams of the second part:

WITNESSETH, That the said party of the first part, by virtue of the authority to him given in and by the said last Will and Testament, and in consideration of the sum of Three Hundred Twenty-four and no/100 (\$324.00) Dollars to him Paid by the said party of the second part (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these Presents does GRANT, BARGAIN, SELL AND RELEASE unto the said party of the second part his Heirs and Assigns forever, ALL THE ESTATE, right, title, interest, property possession, claim and demand whatsoever, both in law and equity, which the said Testator had at the time of his decease; and which the said party of the first part has by virtue of said last Will and Testament of T. H. Reid deceased, of, in and to:

All that certain piece, parcel or lot of land situate, lying and being at Gowansville in Greenville County, South Carolina, containing twelve (12) acres, more or less, and being known and designated as Lot No. 21 on plat of property of the T. H. Reid Estate, recorded in the R. M. C. Office for Greenville County at page 101, Vol. M. Beginning at a point in old road and running thence N. $41\frac{1}{2}$ W. 612 feet to a post oak; thence N. 45 E. 693 feet; thence N. 83 E. 88 feet to a point in road; thence S. 44 E. 292 feet to a bend in road; thence S. 36.40 E. 957 feet to a point in road; thence along the first named road S. 75 W. 510 feet to the beginning corner. Said property is bounded by Evans land on the west and by Lots numbers 20, 22 and 23 of the T. H. Reid property.

Whereas, on or about the 3rd day of October, 1944, C. T. Reid, as Executor of the T. H. Reid Estate advertised for sale at public auction through the Metcalf Realty Company all of the real property owned by the said estate in and near Gowansville, South Carolina, and whereas G. B. TO HAVE AND TO HOLD, all and singular the above described premises unto the said party of the second part his Heirs and assigns, to him and their only proper use and behoof forever; as fully and absolutely as the said party of the first part can and ought to do, pursuant to his authority as aforesaid.
