

EXECUTOR'S TITLE TO REAL ESTATE.

STATE OF SOUTH CAROLINA,
GREENVILLE COUNTY.

THIS INDENTURE, made this 23rd day of October in the year of our Lord one thousand nine hundred and Forty-four between C. T. Reid, as Executor--of the last Will and Testament of T. H. Reid, late of Campobello in the County of Spartanburg and State of South Carolina, deceased, of the first part, and C. T. Reid, of the second part:

WITNESSETH, That the said party of the first part, by virtue of the authority to him given in and by the said last Will and Testament, and in consideration of the sum of One Thousand Fifty and no/100 (\$1050.00) Dollars to him Paid by the said party of the second part (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these Presents does GRANT, BARGAIN, SELL AND RELEASE unto the said party of the second part his Heirs and Assigns forever, ALL THE ESTATE, right, title, interest, property possession, claim and demand whatsoever, both in law and equity, which the said Testator had at the time of his decease; and which the said party of the first part has by virtue of said last Will and Testament of T. H. Reid deceased, of, in and to:

All that certain piece, parcel or tract of land situate, lying and being in Gowansville, Greenville County, South Carolina, and containing 42 acres, more or less. Said lot being known and designated as Lot No. 11 on plat of property of the T. H. Reid Estate, recorded in the R. M. C. Office for Greenville County, Vol. M., page 101. Said property bounded by the Tugaleo Road; property of T. W. Petty and Lots Nos. 9, 10 and 12 of the T. H. Reid property as will be more fully shown by reference to plat above referred to.

Whereas, on or about the 3rd day of October, 1944, C. T. Reid, as Executor of the T. H. Reid Estate advertised for sale at public auction through the Metcalf Realty Company all of the real property owned by the said estate in and near Gowansville, South Carolina, and whereas C. T. Reid was the highest bidder for the said property under the terms announced on the grounds for the sale of the said property. Wherefore, the within deed is made to comply with the terms of sale at said time and place.

TOGETHER WITH ALL AND SINGULAR THE Tenements, Hereditaments, and Appurtenances thereunto belonging, or in anywise appertaining. TO HAVE AND TO HOLD, all and singular the above described premises unto the said party of the second part his Heirs and assigns, to him and their only proper use and behoof forever; as fully and absolutely as the said party of the first part can and outht to do, pursuant to his authority as aforesaid.
