excepting however, servants quarters and garages.
The within grantors, their heirs or assigns, shall not be liable to the within grantee, his
heirs or assigns, for any claim of damages resulting from the operation or maintenance of any
roadways, swimming pool, parks or playgrounds or utilities within the Wildwood Park Area.
These restrictions are not intended as conditions subsequent, but for the protection of
property owners in Wildwood Park, any of whom shall have the right for their protection to institut
