TITLE TO REAL ESTATE

POWER OF ATTORNEY.

KNOW ALL MEN BY THESE PRESENTS that I, William Gordon McCabe, III, hereby revoking all powers of attorney by me at any time heretofore made, do hereby constitute and appoint The South Carolina National Bank of Charleston (Greenville, S. C. Branch) my true and lawful attorney, for me and in my name and stead to receive payment of moneys, sign and endorse checks, give receipts, make and execute sales, assignments and conveyances of any property, real or personal, or any rights in property which I may now have or to which I may hereafter become entitled, to vote any stock which may stand in my name on the books of any corporation and from time to time to execute proxies for the voting thereof, to consent to any corporate action and generally to do and transact any and all business for me and in my name as fully as I might do if personally present, and particularly to do all such acts and things and execute in my name all such instruments as it may deem advisable in connection with the affairs of the estate of my grandfather, William Gordon McCabe, and to deal generally in its uncontrolled discretion with State Planters Bank & Trust Company, Agent, of Richmond, Virginia, including the right to exercise any and all powers and rights vested in me under a written agreement with State Planters Bank & Trust Company dated June 6, 1941, including specifically but not being limited to the right to terminate said agreement in accordance with the terms thereof, and receipt for and receive possession of any funds, securities or other assets to which I may be entitled thereunder.

This power of attorney shall continue in force during my term of service in the armed forces of the United States and thereafter until revoked in writing.

In the event of the merger, consolidation, reorganization or reincorpora tion to which The South Carolina National Bank of Charleston is a party, any banking corporation organized under the laws of the United States of America or the State of South Carolina which shall succeed to the business and acquire the assets, or the greater portion thereof, of The South Carolina National Bank of Charleston, shall be substituted as attorney for said The South Carolina National Bank, with the same force and effect and the same duties and powers as if such successor corporation had been specifically nominated herein.
