Assigns:-

All that certain piece, parcel or lot of land situate, lying and being on the South west side of Claremore Avenue, near the City of Greenville in the County of Greenville, State of South Carolina, known as Lot No. 3, Block L, Section 5 on plat of East Highlands Estates made by Dalton & Neves, Engineers, February, 1941 and recorded in the RMC Office for Greenville County, S. C. in Plat Book K at pages 78, 79 and 80, and having according to said plat the following metes and bounds, to-wit:
