KNOW ALL MEN BY THESE PRESENTS, That SALUDA LAND & LUMBER COMPANY, a corporation organized and existing under the Laws of the State of Delaware, GRANTOR, for and in consideration of the sum of One Dollar (\$1.00) to it paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, and for the further consideration unto the herein named Grantor, its successors and assigns, of all rights of ingress and egress over, upon and across the hereinafter described parcel of ground, together with all the other rights useful, convenient and necessary for the cutting, removal, transporting and manufacturing of the timber and trees located on adjoining lands, has granted, bargained, sold and released, and by these presents does hereby GRANT, BARGAIN, SELL AND RELEASE UNTO HAMLIN BEATTIE AND E. M. BLYTHE, JR., of the County of Greenville, State of South Carolina, GRANTEES, all of its right, title and interest in and to the timber and trees on that certain parcel or plot of ground situate, lying and being within the boundary of that tract commonly known as the C. G. Drake Tract, lying on waters of Fall Creek, and Middle Saluda River, in Cleveland Township, Greenville County, State of South Carolina, and fully described on a plat there of prepared by Howard Wiswall, C. E., as "No. B-XVIII, C. G. Drake" reference to which plat is hereby craved for a full and complete description of the Drake Lands. The parcel of ground from which the timber and trees are hereby released is more particularly described as follows:

Beginning at a stone corner, common to the lands herein described and lands of J. H. Cleveland, et al. and running thence S. 67° 50' W. 1200 feet, crossing Fall Creek to a stake corner; thence S. 23° 30' E. 600 feet to a stake; thence N. 67° 50' E. to a stake in the property line of the lands herein described and lands of J. H. Cleveland, et al; thence N. 23° 30' W. 600 feet to a stone, the beginning corner, containing 16 acres, more or less.
