Wynn and Lura Davis Wynn, our father and mother, deceased, in consideration of the sum of Six Hundred and Ninety (\$690.00) Dollars to us in hand paid at and before the sealing of these presents by SAMUEL AIKEN, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Samuel Aiken, his heirs and assigns forever, all that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, at the intersection of Hunt's Bridge Road with the White Horse Road, having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the juncture of Hunt's Bridge Road and White Horse Road, and running thence along the Hunt's Bridge Road S. 51-30 E. one hundred thirty and seven-tenths (130.7) feet to an iron pin, joint corner with other property of Samuel Aiken; thence S. 4-00 E. one hundred and sixty-five (165) feet to an iron pin; thence S. 51-30 W. one hundred and sixty-five (165) feet to an iron pin, joint corner with Ann Davis land; thence S. 4-00 E. along Ann Davis' land three hundred and fifty-four (354) feet to a stake, W. E. Armstrong's land; thence N. 46-0 E. along the W. E.
