Main Street. (City of Greenville) to Rutherford St. (City of Greenville) - on Route No. 29 - State and Name of Place

County aforesaid, as shown by plans prepared by the State Highway Department, on and over all lands which I (or we) may own in whole or in part, for the purpose of locating, constructing, improving, and maintaining the above described highway with the bridges and causeways thereon. Bounded by lands of Henry Theodore on the east and Townes Street on the west.
