It is understood and agreed that the grantor, its successors and assigns, shall have a right-of-way for a road, not exceeding 30 feet in width, running between parallel lines along the Eastern side of the above-described property a distance of 372 feet. being a strip 30 feet wide across the rear of the property hereinabove described.

It is understood and agreed that with the exception of aforesaid right-of-way, the grantor, its successors and assigns, shall have no right-of-way for a road into and over the above-described property and that the grantees may close all roads on said property with the exception of the 30 foot roadway across the Eastern side of said property, subject to the rights of United States Government under said lease hereinbelow referred to.

This deed is made subject to lease entered into by and between George H. ... Hendricks, Trustee and United States of America on the 10th day of November, 1942, recorded in the Office of the R. M. C. for Greenville County in Deed Book 281, rage 395.

It is understood and agreed that the grantees are to have no claims against the buildings placed on said property by the United States of America under said lease. The grantor reserves the right to purchase from the United States Government the buildings placed on said property; and that should the grantor exercise its option to purchase said buildings from the Government, buildings shall be removed within sixty (60) days from the date of said purchase, and that said option to purchase said buildings shall be exercised by the grantor within six (6) months from the date of the termination of the lease hereinabove referred to. exercisessaid option and removes said buildings, it will leave the grounds in good condition.

The grantor hereby conveys unto the grantees, their heirs and assigns, all water lines, sewer lines, light and telephone lines, and other improvements upon said property, subject to the rights of the United States Government under the lease hereinabove referred to, but the grantees herein will permit the owner or owners of the remaining portion of Tract No. 7. hereinafter referred to, to connect with all water lines, sewer lines, light and telephone lines upon said owner or owners compling with the usual provisions for such connections.
