Known as a part of two tracts one conveyed to me by deed from W. T. Davis and one by deed from R. A. F. Davis, and in the Subdivision as tract No. 6 adjoining lands of Frank Hodgens, Ed. Simpson and tract No. 5. Beginning on an iron pin S. E. corner thence running N. 35 1/4 W. 14.20 to an iron pin, thence S. 59 W. 5.88 to an iron pin on Frank Hodgens line thence N. 36 W. 10.76 to a stone o. m. thence N. 58 1/2 E. 11.66 stone thence S. 36 E. 16.72 to an iron pin, thence S. 1 E. 10.00 to the beginning corner and contains 18.70 acres, the same more or less.

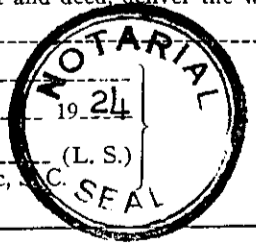
