The Judson Mills further reserves to itself, and its successors and assigns, all water pipe lines, valves, fittings, hydrants, and ot apparatus used in connection with and forming a part of the water distribution system of Judson Mills No. 2 Village, which may be located upon the lot herein conveyed, but granting and not reserving all house lines, together with the right, privilege and easement in perpetuity to go upon the land for the purpose of maintaining in operation the said water pipe lines as same are now located, to remove and relocate said lines so as to run in or along the streets, and to operate maintain the lines as so relocated." As a part of the consideration for this deed the Grantee herein assumes and agrees to pay that certain mortgage in the principal sum of Sixteen Hundred (\$1600.00) Dollars, executed be the Grantor herein to Mary T.
