(the receipt whereof is hereby acknowledged) have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said B. R. Traynham, his heirs and assigns forever:

All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina.

All that piece, parcel or lot of land, in the State of South Carolina, County of Greenville, in Butler Township, being known and designated as Tract No. 22, of the property of Lucy L. Hindman, according to unrecorded plat made by W. J. Riddle, surveyor, October, 1939, and having, according to said plat, the following metes and bounds, to-wit:
