KNOW ALL MEN BY THESE PRESENTS, That I, J.H. Barnette, in the County and State aforesaid, in consideration of the sum of Ten (\$10.00) Dollars, to me in hand paid at and before the sealing of these presents by Greer Oil Mill and Feed Company, Incorporated, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the Greer Oil Mill and Feed Company, Incorporated, its successors and assigns:

The right-of-way, easement and privilege of installing an eight-inch water line, connected to and running from ~~from~~ the City of Greer water main on Trade Street, along the Northern side and near the boundary line of that certain lot of land belonging to the said J.H. Barnette, on the East side of South Trade Street in the Town of Greer, identified as House No. 74, bounded by property of the Oil Mill and others, including the right to excavate ditch for line and connections as shown by a certain map of the property of the Greer Oil Mill and Feed Company prepared by Globe Automatic Sprinkler Company, with the additional right and privilege of replacing or repairing said water line, if necessary, at any time.

It is further agreed, that the Greer Oil Mill and Feed Company shall replace the soil over the water line after installation, or at any time thereafter in the event of necessary repairs or replacements.
