I, E. INMAN, Master in and for the County aforesaid, SEND GREETINGS:

WHEREAS, Bessie Q. Wood, in her own right, and as Administratrix of the Estate of I. M. Wood, deceased

on or about the 7th day of July in the year of our Lord nineteen hundred and thirty-seven exhibited her complaint in the Court of Common Pleas, for the County aforesaid, against T. J. Wood, et al

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 21st of Dec. 1945 ~~May 1945~~ and 29th April, 1946, and such proceedings were had therein as resulted in a Decree

of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN, Master in and for the County aforesaid, to J. W. Harvey and Myrtle F. Harvey

for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgement Roll No. E-10572)

NOW, THEREFORE, Know All Men by These Presents, That I, E. INMAN, Master in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, and upon receipt of \$3600.00

HAVE GRANTED, conveyed and released, and by these Presents, DO GRANT, convey, and release unto the said

J. W. Harvey and Myrtle F. Harvey

All that certain piece, parcel and tract of land, situate and lying and being in Chick Springs Township, County and State aforesaid, and containing 44.72 acres, more or less, as shown by a plat of the property of the I. M. Wood Estate made by H. S. Brockman, Surveyor, on March 16, 1946, said plat being of record in the R. M. C. office for Greenville County in Plat Book "P" at Page 35, and having the following metes and bounds and courses and distances as shown by said plat, to-wit:

BEGINNING AT a birch stump on the bank of the Enoree River and in line of the 51 acre tract of the I. M. Wood property and running thence along the line of this 51 acre tract N. 69-00 E. 19.58 chains to a point in the center of a Public Road; thence along the center of said road N. 37-30 W. 15.14 chains to a point in the center of said road; thence continuing along the line of the center of said road N. 49-45 W. 9.00 chains to a point in the center of said road; thence S. 65.35 W. 3.47 chains to an iron pin; thence S. 20-00 W. 2.05 chains to a locust; thence S. 16.00 W. 6.64 chains to an iron pin; thence S. 69-40 W. 12.75 chains to birch on Enoree River; thence along the meanderings of said river as the line to the point of beginning."

The grantees are to pay all taxes on the above property beginning with the year 1946.
