(the receipt whereof is hereby acknowledged) have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said

Harold Owen, his heirs and assigns forever:

All of that piece, parcel or strip of land situate, lying and being in the County of Greenville, State of South Carolina, in the City of Greenville, on the West side of Elizabeth Street and being known and designated as a portion of Lot P according to Plat of North Hills prepared by Dalton & Neves, Engineers, April 1925, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book H, at page 90, and being shown on a revised plat of Lots P and Q of North Hills prepared by L. A. Webb, June 22, 1946, which plat is of record in the R. M. C. Office for Greenville County, in Plat Book B at page 183 and having according to said revised plat the following metes and bounds:

Beginning at an iron pin on the West side of Elizabeth Street original joint front corner of Lots P and Q and running thence along the common line of Lots P and Q, N. 21-30 W. 94.1 feet to an iron pin on the face of a rock retaining wall; thence along the face of the rock retaining wall, S. 82-52 W. 12.5 feet to an iron pin on the face of said rock retaining wall; thence S. 27-38 E. 98.6 feet to an iron pin on the West side of Elizabeth Street, which pin is 2 feet in a Southwesterly direction from the original joint front corner of Lots P and Q; thence N. 35 E. 2 feet to an iron pin, the beginning corner.

This being part of the same property conveyed to the grantor herein by Sophie E. Reames by deed dated June 1, 1945, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 277, at page 140.
