Beginning at an iron pin on the Southern side of Long Hill Street, joint Northern corner of Lots Nos. 80 and 81, and running thence with Long Hill Street S. 87-04 E. 30 feet to a point in line of Lot No. 80; thence S. 2-56 W. 160 feet to a point in rear line of Lot No. 80; thence W. 87-04 E. 30 feet to an iron pin, joint rear corner of Lots Nos. 80 and 81; thence with the dividing line of said lots N. 2-56 E. 160 feet to the point of beginning.
