TITLE TO REAL ESTATE

LEASE AGREEMENT.

All that certain piece, parcel or lot of land with the building thereon located at No. 11 Pendleton Street in the Town of West Greenville, State and County aforesaid, fronting approximately 19 feet on Pendleton Street.

It is understood and agreed that the Lessees shall be entitled to said premises for a term of three years beginning on the First day of September, 1946, and ending on the Thirty-first day of August, 1949, and the Lessees herein do hereby expressly agree to pay a monthly rental in the sum of Thirty-Five and no/100 (\$35.00) Dollars for and during the term hereinabove set out, said payments to be made to the Lessor on the first day of each and every successive calendar month, in advance, beginning on the First day of September, 1946, and continuing during the entire term as hereinabove set out.

It is understood and agreed that the Lessor herein shall keep in repair the roof and the outside walls of the building, including the plate-glass windows, and the floor of the inside of the building, but the Lessees shall have the right to make any improvements and alterations upon the premises, provided said premises shall be left in as good condition as the time the Lessees took possession at the beginning of this lease, reasonable wear and tear excepted.

To have and to hold the aforesaid premises unto the Lessees hereinabove named, and their Executors, Administrators and assigns for and during the aforesaid term.
