Assigns, forever:

All those certain pieces, parcels or lots of land with the buildings and improvements thereon situate, lying and being on Alaska Avenue (formerly known as Morningside Drive) in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lots 2, 4, 7, 8, 9 and 11 on plat of Parkview made by Dalton & Neves, Engineers, June 1942, recorded in the R. M. C. Office for Greenville, County, S. C. in Plat Book "M", page 49, and having such metes and bounds as are shown on the plat above mentioned.

This conveyance is made to the Grantee herein in liquidation of the assets of R. E. Hughes Co., and the sole consideration is the cancellation and retirement of the capita stock held by the grantee in said corporation.

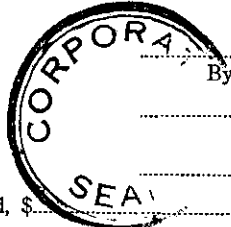
