Medlin, his heirs

and assigns;

All that certain piece, parcel or lot of land situate, lying and being on the North side of the Oil Mill Road, Greenville County, South Carolina, about two miles from the city limits of the City of Greenville, being known and designated as lot No. 6 of property of Central Realty Corporation, according to plat of said property recorded in the R. M. C. Office for said Greenville County in Plat Book B, Page 82, and having according to said plat the following metes and bounds, to wit:

BEGINNING at a point on the North side of said Oil Mill Road at the joint corner of lots Nos. 6 and 7, and running thence along the North side of said Oil Mill Road, S. 77-22 W. 51.3 feet to a stake at the joint corner of lots Nos. 5 and 6 according to said plat; thence along the joint line of said lots Nos. 5 and 6, N. 1-32 E. 145.3 feet to a stake at the joint rear corner of lots Nos. 5 and 6; thence N. 85-48 E. 50 feet to a stake at the joint rear corner of lots Nos. 4 and 6 on the line of lot No. 7; thence along the joint line of lots Nos. 6 and 7, S. 1-32 W. 137.8 feet to the beginning point, joint corner of lots Nos. 6 and 7 on the North side of the Oil Mill Road.
