in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Billie S. Flinn all that piece, parcel or lot of land in Greenville City Greenville County, State of South Carolina.

on the South side of Alaska Avenue and designated as Lot #7 of Parkview, a plat of which is recorded in the R. M. C.'s Office for Greenville County in Plat Book "M" at Page 49 and having according to said plat the following metes and bounds, courses and distances to wit:

BEGINNING at an iron pin on the South side of Alaska Avenue which iron pin is 200 feet in an Easterly direction from the Southeastern intersection of Alaska Avenue and Neely Drive (This point is taken by projecting the line of the two streets since the intersection is a curve instead of a corner.), joint corner of Lots #7 and 8; thence along the joint line of said lots S. 36-17 E., 150 feet to an iron pin, rear joint corner of said lots; thence N. 53-43 E., 50 feet to an iron pin, rear joint corner of Lots #6 and 7, thence along the joint line of said lots N. 36-17 W., 150 feet to an iron pin in the line of Alaska Avenue, thence along the Southern side of Alaska Avenue S. 53-43 W., 50 feet to the point of beginning.
