All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, at the Southwest corner of the intersection of North Main Street and West Coffee Street, and having the following metes, bounds, courses and distances, to-wit:
