to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto David McD. Ketchum,

his heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being on the South side of Piney Road, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 2 of a section known as Shrinewood, according to plat of Central Realty Corporation property, made by W. J. Riddle July 1946, recorded in the R. M. C. Office for said Greenville County in Plat Book B, page 86, and having according to said plat the following metes and bounds, to-wit:

Beginning at a stake on the South side of said Piney Road at the joint corner of Lots Nos. 1 and 2, and running thence with said Piney Road, S. 73-0 W. 75 feet to a stake at the joint corner of lots Nos. 2 and 3; thence along the joint line of said lots Nos. 2 and 3, S. 17-0 E. 231 feet to a stake at the joint rear corner of lots Nos. 2 and 3; thence N. 73-0 E. 75 feet to a stake at the joint rear corner of Lots Nos. 1 and 2; thence along the joint line of said lots Nos. 1 and 2, N. 17-0 W. 231 feet to a stake at the joint corner of lots Nos. 1 and 2 on the South side of Piney Road, the point of beginning.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinabove named, and his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinabove named, and his heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

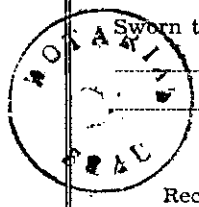
