to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Melcolm W. Dunlevie, his heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being on the Western side of Clairemont Drive, near the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 11 of Central Realty Corporation property according to a plat of said property made by W. J. Riddle, July 1946, recorded in the R.M.C. Office for said Greenville County in Plat Book B, page 86, and having according to said plat the following metes and bounds, to-wit:
