to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Lloyd G. Cartee, his heirs and assigns:

All that certain lot of land situate, lying and being in Greenville County, South Carolina, just outside the city limits of the City of Greenville, being known and designated as lot No. 7 on plat of resubdivision of property owned by Central Realty Corporation made by Pickell & Pickell, June 20, 1946, recorded in the R. M. C. Office for said Greenville County in Plat Book B, page 199, and having according to said plat the following metes and bounds:

BEGINNING at a point on the North side of Durham Street which is the joint corner of lots Nos. 8 and 7, and running thence S. 69-30 W. 60 feet to a point which is the joint corner of lots Nos. 7 and 6, according to said plat; thence along the joint line of said lots Nos. 7 and 6, N. 22-00 W. 150 feet to a point which is the joint rear corner of said lots Nos. 6 and 7; thence N. 69-30 E. 60 feet to the joint rear corner of lots Nos. 8 and 7; thence along the joint line of said lots Nos. 8 and 7, S. 22-00 E. 150 feet to the beginning corner, joint corner of lots Nos. 8 and 7 on the North side of Durham Street.
