WHEREAS, B. A. Bennett, as Executor of the Will of W. R. Bailey, deceased, et al, on or about December 5th, 1946, exhibited their complaint in the Court of Common Pleas for the County of Spartenburg, against Johnny Bailey, et al, demanding judgment in relation to the partition of the premises hereinafter mentioned and described; and the cause being at issue came on to be heard on the 23rd day of December, 1946, and such proceedings were had therein as resulted in a Decree of the said Court, whereby it was adjudged and decreed that the said premises hereinafter described be conveyed by LeRoy Moore, Master for Spartenburg County, unto D. C. Bailey, on the terms and for the purposes mentioned in the said Decree, as by reference thereto on file in said Court will appear; and the terms of said Decree having been met, NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, That I, LeRoy Moore, Master in and for the County of Spartanburg, said State, in consideration of the sum of three dollars, and the terms of said Decree, to me paid by D. C. Bailey, the receipt whereof is hereby acknowledged, have granted, bergained, sold, released and conveyed and by these Presents do grant, bargain, sell, release and convey unto the said D. C. Bailey, his heirs and assigns forever:

That certain lot of land and all improvements thereon, in the Town of Greer, Chick Springs Township, Greenville County, S. C., in School District 9-H, on North Avenue (also known now as Cemetery Street), and described as follows:

Beginning at a stake on said North Avenue (or Cemetery Street), corner of the former J. D. Wood's land, and runs thence with Wood's line, 235 feet to iron pin on (former) T. T. Westmoreland's line; thence along the Westmoreland line, 50 feet to iron pin on J. D. Wood's land; thence along Wood's line  $2\frac{1}{4}2\frac{1}{2}$  feet to stake on said Avenue or Street; thence along said Avenue (or Street) 50 feet to the beginning corner; and being the same conveyed to W. R. Bailey by deed of L. R. Ross, recorded in Vol. 28 at page 495.
