TITLE TO REAL ESTATE

- 9. In the event any installment of the guaranteed rental shall be in arrears and unpaid for a period of sixty days or in the event the Lessee shall be adjudicated, bankrupt, voluntary or involuntary, or shall be placed in the hands of a receiver or shall make an assignment for the benefit of its creditors, or fails to comply with any of the provisions of this lease, and shall be notified in writing by the Lessors of such default or violation, and fails within a period of fifteen days thereafter to remove such default or violation, then in such event this lease shall terminate at the option of the Lessors.
- 10. It is further understood and agreed that the Lessee herein will not assign this lease or sub-lease said premises or any portion thereof without first obtaining the written consent of the Lessors herein.
- 11. It is further understood and agreed that this lease shall supersede all leases or lease agreements now in effect or which may have theretofore been made or entered into by and between the parties hereto, and that this lease agreement shall inure to the benefit of and shall be bearing on the parties hereto and their respective heirs, successors, administrators, executors and assigns.
