to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Lonnie Burdette Denton, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, being known and designated as Lot No. 8 of Block D, of a subdivision known as Sunny Slope, as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book F, at page 86, and having the following Metes and bounds, to-wit:

BEGINNING at an iron pin on the southwest side of First Avenue at the corner of Lot No. 9, of Block D, which point is 46.8 feet southeast of the intersection of a 20-foot unnamed street, and running thence along the southwest side of First Avenue, S. 66-11 E. 50 feet to an iron pin at the corner of Lot No. 7; thence along the line of Lot No. 7, S. 23-49 W. 150 feet to an iron pin; thence N. 66-11 W. 50 feet to an iron pin at the rear corner of Lot No. 9; thence along the line of Lot No. 9, N 23-49 E. 150 feet to the beginning corner.
