to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Charlie Taylor, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being on the Southern side of Durham Street, near the City of Greenville, County of Greenville, State of South Carolina, known and designated as lot No. 14 of a resubdivision of Central Realty Corporation property, according to plat thereof made by Pickell & Pickell, June 20, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book B, page 199, and having according to said plat the following metes and bounds:
