When said remains have been removed and the abandonment of said slave cemetery completed, the Lessor will notify Lessee thereof in writing. Lessee shall not go into possession under this lease nor begin any mining operations on the demised premises until said abandonment of said slave cemetery has been completed and said notice of such abandonment given as hereinabove provided for.

- 6. It is also agreed by both parties that the Lessor will save harmless the Lessee from all claims or demands for damages incident to the mining of said minerals within the bounds of the described premises.
- 7. When, in the opinion of Lessee, the ore of commercial grades has been mined from the premises hereby demised, the Lessee shall have the right to cancel this lease on ninety days! written notice to Lessor. Upon such notice being given, this lease shall terminate and each of the parties hereto shall be released from further liability hereunder.
- 8. This lease is binding upon and enures to the benefit of the heirs, successors, executors, administrators and assigns of the Lessor and Lessee.
