TITLE TO REAL ESTATE

This Lease, Made this the 16 day of January, 1947, by Mrs. E. L. Martin of the above State and County, party of the first part, hereinafter called the "Lessor", to Duke Power Company, a corporation organized under the laws of the State of New Jersey, party of the second part, hereinafter called the "Lessee", WITNESSETH:

That for and in consideration of the rental sum of one Hundred (\$100.00), to be paid by the Lessee to the Lessor in advance, the Lessor hereby lets and leases unto the Lessee for and during the term of five (5) years from Aug. 7, 1947, a right of way 68 feet in width, upon and across that tract of land belonging to us. (me) situate in the above County and State, bounded by the lands of Mrs. Montez L. Harris, Plantation Pipe Line and others, the center line to be as staked out on the ground, for the purpose of constructing, operating and maintaining a line of poles, together with such wires, conductors and other apparatus and appliances, as in the opinion of the Lessee may be advisable or desirable for and in connection with transmitting or distributing electric power; also, including the right at all times during the continuance of this lease to enter upon said tract of land for the purpose of constructing and making necessary or desirable repairs, alterations, substitutions or additions to and inspections of said line, together with the right to keep said 68-foot strip clear of all trees, structures and other objects except those placed thereon by the Lessee.

IT IS AGREED that the grantor may use said strip of land for growing such crops and maintaining such fences as may not interfere with the use of said right of way by the Power Company for the purpose hereinabove mentioned.

Upon the expiration or other termination of this lease, the Lessee will remove its electric line and other property from said right of way.
