on the north side of the White Oak Road, and being known and designated as Lot No. 2, and a portion of Lot No. 3, of the property of E. E. Snipes, as shown on plat thereof recorded in the R.M.C. office for Greenville County in Plat Book H, at Page 194, and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the north side of the White Oak road at the corner of Lot No. 1, and running thence along the north side of said White Oak Road, N. 86-50 W. 110 feet to an iron pin, which point is 40 feet west of the joint corner of Lots Nos. 2 and 3; thence N. 8-40 E. 591.3 feet to an iron pin in line of the property of E. M.
