All that piece, parcel or lot of land in City of Greenville Greenville County, State of South Carolina. in Ward Five

BEGINNING at an iron pin at the corner of Pendleton and Wardlaw Streets, thence N. 19 1/2 W. 101 feet to an iron pin 3x; thence S. 70 1/2 W. 27 1/2 feet to a stake; thence S. 19 1/2 E. 101 ft. to Pendleton St.; thence along the Street N. 70 1/2 E. 27 1/2 ft. to the beginning corner, This lot is represented by a plat made by J. N. Southern, D. S., of date Nov. 29, 1893, and is known as Lot #5 in the division of the real estate of Thomas J. Turner, deceased. Being the same property conveyed to Phillip Najar by William Hoesh by deed dated July 15, 1908 and recorded in the R.M.C. Office for Greenville County in Deed Book ZZZ at page 46.

ALSO:

All that certain piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, at the intersection of Vardry St. and Green Ave. and on the north side of said Vardry St. and Green Ave., fronting 5.3 ft., more or less, on the north side of Green Avenue, 118.3 ft., more or less, on the north side of Vardry St., having the depth on the West side of 213 ft., more or less, and on the east side of 278.8 ft., more or less, and being 102.2 ft., more or less, wide in the rear. Being the same property conveyed to Philip H. Najar in two separate parcels by W.C. Hopkins by deed dated August 14, 1908, recorded in the R.M.C. Office for Greenville County in Deed Book 4 at page 124, reference to which is hereby carved for a more complete description.

The said Philip H. Najar died intestate on or about January 10, 1915, leaving as his sole heirs at law his wife, Rosa C. Najar, and his four children: Sallie N. Alala, George Najar, Julia N. Polito and Queen Najar. / The said Julia N. Polito died testate Nov. 7, 1943 leaving of force her last will and testament on file in the office of Probate Court for Greenville County in Apt. 471, File 1, by the terms of which George Najar and Queen Najar were devised the one-third interest of Julia N. Polito in said property.

George Najar died testate Oct. 13, 1945 leaving of force his last will and testament on file in office of Probate Court for Greenville County in Apt. 503, File 17, by the terms of which he devised his undivided one-half interest in the above described property as follows:

- (1) To grantor herein an undivided one-sixth interest (1/3 of Geo. P. Najar's 1/2 interest)
- (2) to Gladys C. Beam who was at that time his widow, an undivided one-sixth interest (1/3 of Geo. P. Najar's 1/2 interest)
- (3) to Queen Najar an undivided one-sixth interest (1/3 of Geo. P. Najar's 1/2 interest)

The above mentioned Rosa C. Najar died intestate on or about December 6, 1938, leaving as her sole heirs at law the following children: George Najar, Sallie N. Alala, Julia N. Polito and Queen Najar.
