(the receipt whereof is hereby acknowledged) have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said

E. F. Bayne, his heirs and assigns forever:

All that certain piece, parcel or tract of land situate, lying and being in Saluda Township, County and State aforesaid, and situate on the east side of Greenville-Hendersonville Road, said road being State Highway No. 25, and about 15 miles north of the City of Greenville, near Lima Church on branch waters of North Saluda River, and being more particularly described as follows, to-wit:

Beginning at a white oak on the east side of State Highway No. 25 and running thence N. 70 3/4 E. to bend; thence N. 70 3/4 E. 1.38 to bend; thence N. 68 3/4 E. 2.74 to bend; thence S. 72 1/4 E. 1.70 to poplar; thence S. 73 E. 6.08 to stone between pines; thence S. 13 1/4 E. 5.60 to stone; thence S. 84 W. 10.28 to an iron pin at corner of tracts Nos. 7 and 8 of E. F. Bayne's lands on eastern side of State Highway No. 25 and intersection of private road with said highway; thence along said private highway leading from said highway in an easterly direction 215 feet to an iron pin; thence W. 165 feet to State Highway No. 25; thence along said highway in a northerly direction 400 feet to the beginning corner, and being the same tract of land conveyed to us by E. F. Bayne by his deed dated January 16, 1945, and recorded in the R. M. C. Office for Greenville County in Volume 271, page 162.

As a part of the consideration of this conveyance, the grantee herein agrees and does hereby agree to mark satisfied in full and canceled a certain note in the sum of \$4000.00 dated January 16, 1945, and secured by a real estate mortgage over the above described premises and given by us as the balance of the purchase price of said land when same was purchased by us from the said E.
