to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Wilfred F. Blackwell, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being on the Southeastern side of Langley Drive, near the City of Greenville, County of Greenville, State of South Carolina, known and designated as lot No. 59 of Langley Heights, according to plat thereof made by Dalton & Neves, June 1937, recorded in the R.M.C. Office for said Greenville County in Plat Book N, Page 133, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southeastern side of said Langley Drive which is 213. feet from the intersection of Langley Drive with Hawthorne Lane, at the corner of lot No. 58, and running thence along the line of said lot S. 31-37 E. 227 feet to an iron pin at the rear corner of lot No. 58; thence along the line of a 15 foot alley, S. 68-06 W. 50.7 feet to a stake at the rear corner of lot No. 60; thence along the line of said lot No. 60, N. 31-37 W. 218.5 feet to a stake on Landley Drive, corner of lot No. 60; thence along the said Langley Drive, N. 58-23 E 50 feet to the point of beginning.
