All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, near Paris Station being known and designated as Lot 124 according to the plat of Super Highway Home Sites made by Dalton and Neves, May 1946 as recorded in Plat Book "P", at Page 53, subject to building and other restrictions as set forth in an instrument recorded in Deed Book 291, pages 369 and 370. Said records are in the office of Register Mesne Conveyance for Greenville County. Said lot has the following metes and bounds, to-wit:
