their heirs and assigns, forever:All that certain piece, parcel or lot of land with the build-  
ings and improvements thereon situate, lying and being on the West  
side of Prince De Leon Drive, near the City of Greenville, in the  
County of Greenville, State of South Carolina, in Section 10, Lot  
No. 9 of Part of Land on Drive Highway, made by William C. Webb,  
of us, August 1937, recorded in the Office of Register of Deeds,  
Greenville County, S. C. in Plat Book "D", Page 2 of 1938, and plat  
pertaining to said tract, the following and contains, tract:A Wall 6' 6" at an iron rail on the West side of Prince De Leon Drive  
at point front corner of Lots 8 and 9 and running along the front of
