- . 8. The Tenant will not use, nor permit said premises to be used, for any unlawful purpose, nor permit thereon any t ing which ray become a nuisance, nor will it do or permit to be done, on said premises anything which may render void or voidable any policy of fire insurance on said premises, nor which may cause the owner of the building to have to paw a fire insurance premium at a rate in excess of that which he is now required to pay.
- 9. If the Tenant shall make any assignment for the benefit of creditors, or shall be adjudged a bankrupt, or if Receiver is appointed, then the Landlords, may, upon giving the Tenant ten days' notice in writing, terminate the right of possession of the property by Tenant, and mam, at their option, terminate this lease as in the case of any violation by the Tenant of any of the terms, covenants or conditions herein.

In consideration of the covenants and agreements on the part of the Landlords, the Tenant agrees to the acceptance of the above lease and to pay the rental in the manner hereinabove stipulated.
