

All that certain piece, parcel or lot of land situate, lying and being on the East side of Carolina Avenue, near the City of Greenville, in the County of Greenville, State of South Carolina, being shown as Lot No. 5, Block F, Section 3, on Plat of East Highlands Estates, made by Dalton & Neves, Engineers, May, 1940, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "K", Page 36, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Carolina Avenue at joint front corner of Lots 4 and 5 of Block F, said pin also being 321.5 feet in a Southerly direction from the Southeast corner of the intersection of Carolina Avenue and Fore Avenue and running thence with the line of Lot 4, N. 73-33 E. 175 feet to an iron pin on the West edge of a five-foot strip of land reserved for utilities; thence with the West edge of the five-foot strip of land reserved for utilities, S. 13-14 E. 90 feet to an iron pin; thence with the line of Lot 6, S. 77-29 W. 175 feet to an iron pin on the East side of Carolina Avenue; thence with the East side of Carolina Avenue; thence with the East side of Carolina Avenue, N. 13-01 W. 78 feet to the beginning corner.
