

County, State of South Carolina, on the north side of Foster Street, and having the following metes and bounds:

HEGINNING at corner of Lot No. 25 on said Street, and running thence with said Street, S. 62-15 K. 41 feet to corner of Lot No. 27; thence N. 30-30 E. with line of Lot No. 27, 155 feet to Finley's line; thence with Finley's line N. 68-30 W. 41 feet to corner of Lot No. 25; thence with line of Lot No. 25, S. 30-30 W. 149.8 feet to the beginning corner, being Lot No. 26 of a subdivision, plat of W. D. Neves, July 25, 1914, plat recorded in Plat Book C, page 226, being the same property conveyed to the late Hattie Shumate by Frank B. Foster under date of August 24, 1932, deed recorded in Book 166, at page 252, and being the same conveyed to Frontis Keys Chandler by John W. Gantt by deed dated November 13, 1947, and recorded in Book 327, page 23, the said Frontis Keys Chandler having thereafter conveyed an undivided one-half interest therein to Harold R. McGee.

Also that other lot of land in the Township, County and State aforesaid, adjoining the above described lot of land, being on the north side of Foster Street, and having the following metes and bounds

BEGINNING at an iron pin on the north side of Foster Street at corner of Lot No. 26, and running thence with said Street, S. 64-50 B. 41 feet to an iron pin; thence N. 30-30 E. 160.2 feet to an iron pin in line with Finley and Lot No. 27; thence with the dividing line of Finley and Lot No. 27, N. 68-30 W. 41 feet to an iron pin, corner of Lots Nos. 26 and 27; thence with the dividing line of Lots Nos. 26 and 27, S. 30-30 W. 155 feet to an iron pin in edge of Foster Street, the beginning corner, and being Lot No. 27 as shown on a plat made by W. D. Neves for W. A. Bates and recorded in Plat Book C, page 226, and being the same lot of land conveyed to the late Hattie Shumate by E. E. Watson by deed dated March 15, 1928, and recorded in Book 109, page 357, and being the same conveyed to Frontis Keys Chandler by John W. Gantt by deed dated November 13, 1947, and recorded in Book 327, page 19, the said Frontis Keys Chandler having thereafter conveyed an undivided one half interest therein to Harold R. McGee.
