

all that piece, parcel or lot of land in ----- Greenville --- Township, Greenville ---

County, State of South Carolina, in that section known as said tract being two miles north of the City of Greenville on Blue Ridge Drive between King Street and the Ferry Road, said lot having the following lines, courses and distances:-

Beginning at an iron pin on the northern edge of Blue Ridge Drive (a) foot sidewalk running along Blue Ridge Drive, said pin being the joint front corner of lots numbered eighteen (18) and nineteen (19), said running thence along the northern edge of said sidewalk on Blue Ridge Drive, L. 87-37 .., sixty (60) feet, to an iron pin, joint front corner of lots seventeen (17) and eighteen (18); thence along the southern line of lots seventeen (17) and eighteen (18); thence along the southern line of lots twenty-seven (27) and twenty-nine (29), W. 33-40 .., sixteen (16) feet, to an iron pin; thence along the rear line of lot twenty-six (26) and the western line of lot nineteen (19), N. 26-11 .., two hundred and six (311) feet, to an iron pin on the northern edge of said sidewalk running along Blue Ridge Drive, the beginning corner, said lot being known and also noted as lot number nineteen (19) on plat of said property recorded in the office of the Register of Deeds Conveyances for Greenville County, I. D. book "K" at page 300, which plat is heretofore referred to and made a part hereof.

Said property is in a restricted district, and is subject to the following restrictions, which constitute a part of the description thereof, and shall be effective for a period of ten years from the date hereof:-

- (1) Said property shall be used for residence purposes only.
- (2) No residence shall be erected thereon at a cost of less than three thousand (\$3,000.00) dollars.
- (3) No house shall be erected thereon after the northern edge of said sidewalk running along Blue Ridge Drive than twenty (20) feet.
- (4) Said property shall not be sold to any person of African descent.
