of South Carolina., located on the South side of Ben Street, and designated as lot No. 11, according to a revised plat of McDaniel Heights made by Dalton & Neves, Engineers, October 19, 1947, which said revised plat is recorded in the R. M. C's Office for Greenville County in Plat Book R, at Page 193, and having according to said revised plat the following metes and bounds, courses and distances, to-wit:
