all that piece, parcel or lot of land in ______Greenville___ Township. Greenville_____County. State of South Carolina, on Paris Mountain "venue between Beacon Street and the Franklin Road, in the Sans Bouci section of Greenville County, about two miles north of the city of Greenville, said lot having the following lines, courses and distances:-

Beginning at an iron pin on the southern edge of a five (5) foot sidewalk running along Paris Mountain Avenue, said pin being the joint front corner of lots numbered sixteen (16) and seventeen (17); thence along the western line of lot seventeen (17), S. 6-10 E., one hundred and eighty-four and (184) feet to an iron pin, rear corner of lots sixteen (16) and seventeen (17); thence along the rear line of lot seven (7), S. 80-0 W., seventeen and eight tenths (17.8) feet to an iron pin; thence in a direct line one hundred and eighty-four (184) feet, more or less to an iron pin in the middle of thefront of lot sixteen, on the southern edge of said sidewalk running along Paris Mountain Avenue; thence along the southern edge of said sidewalk, N. 84-28 E., thirty (30) feet, to an iron pin, the beginning corner, said lot being the eastern half of lot sixteen (16), as shown on Plat of said property recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book "I" at page 150, which plat is hereby referred to and made a part hereof.
