

R. E. Dalton, Engineer, March	1946, recorded in the R. M. C. Office for Greenville
County in Plat Book "P", page	15, and having according to said Plat, the following
metes and bounds. to-wit:	

BEGINNING at an iron pin on the East side of Meadors Avenue, joint corner of lots Nos. 58, and 59 and running thence with line of lot No. 59, N. 69-42 E., 200 feet to an iron pin; joint corner of lots Nos. 58, 59, 71 and 72; thence with line of lot No. 72, N. 20-18 W., 105 feet to an iron pin on the South side of Churchill Circle; thence with Churchill Circle, S. 74-15 W., 56.3 feet to an iron pin; thence still with Churchill Circle, S. 65-20 W., 121.4 feet to an iron pin; thence in a curved line, S. 22-51 W., 34 feet to an iron pin on the East side of Meadors Avenue; thence with Meadors Avenue, S. 20-18 E., 76.9 feet to an iron pin the beginning corner.

Included in then above consideration is the right to tap a two (2) inch water line owned by the Grantor. GRANTOR to pay 1947 taxes.

This is a portion of the property conveyed by Mary I. Meadors to MARSMEN, INC. by Deed recorded in the R. M. C. Office for Greenville County in Deed Book 290 at page 143, and a portion of this land, including the above lot, is being developed as a restricted residential district and is sold subject to the following restrictions, which constitute a part of the Consideration hereof, and shall be effective for a period of fifty (50) years from the date hereof:

- 1- Said property is to be sold or used for residential purposes only.
- 2- No residence shall be erected thereon at a cost of less than \$5,000.00.
- 3- No building to be erected nearer than 30 feet from Meadors Avenue.
