ents do grant, bargain, sell and release unto the said RALPH B. SPEEGLE, His Heirs and Assigns, Forever:

All that certain piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, in the subdivision known as Marshall Forest about three miles from the Greenville County Courthouse, and having the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the Northeast side of Brookside Way, said iron pin being at the joint corner of this property and other property of the grantor, and continuing thence S. 25-30 E. 176 feet to an iron pin; thence N. 66-35 E. 402.9 feet to an iron pin at the banks of Reedy River; thence with said Reedy River, N. 42-28 W. 159 feet to an iron pin; thence N. 31-50 W. 140.8 feet to an iron pin at the banks of Reedy River; thence S. 66-35 W. 260.8 feet to an iron pin on Brookside Way; thence along Brookside Way, S. 15-46 E. 52.1 feet to an iron pin; thence continuing along the curve of Brookside Way, the chord of which is S. 24-43 W. 91.8 feet to an iron pin at the beginning corner.
