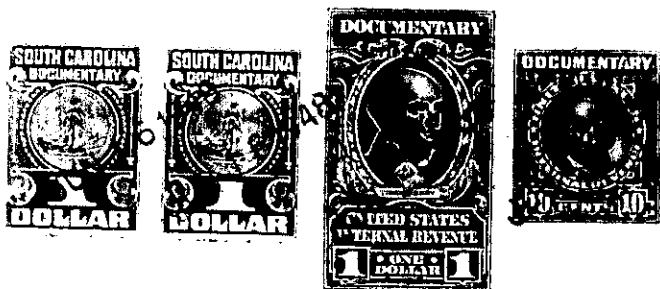

assigns forever

all that piece, parcel or lot of land in Highland Township, Greenville

County, State of South Carolina, lying on the western side of the Greer-Cowansville Road (now State Highway No. 14) being a part of the lot conveyed to me by deed recorded in the office of the R. M. C. for Greenville County in Deed Book 43 at page 511 and part of another tract formerly owned by Richard Kemp, the Kemp deed being recorded in Vol. 9 at page 339, being bounded on the north and west by other lands of myself, on the east by the said State Highway No. 14 and the old Rutherford road (now abandoned) and lands formerly of the W. K. Hill Estate and on the south by lands Crover Turner, and having the following courses and distances, to wit :-

Beginning on a nail and stopper in the center of the State Highway No. 14, joint corner of the former W. K. Hill tract, and run thence with the line of the said tract and a ditch S. 33-45 W. 147 feet to a stake in the old Rutherford and Greenville road; thence with the said old road S. 0-55 W. 100 feet to a bend; thence S. 11-40 E. 215 feet to a stake in the said old road and on the Crover Turner line; thence with the said line S. 72-45 W., crossing a branch, 72 feet to a stake on the said line; thence a new line N. 11-40 E. 580 feet to a stake on the west side of the branch; thence N. 78-20 E. 249 feet to a nail and stopper in the center of the State Highway No. 14 (stake back on line at 15 feet); thence with the center of the said highway S. 23-32 E. 100 feet to a bend; thence S. 14-37 E. 131 feet to the beginning corner, and containing Two and Four Tenths (2.4) Acres, more or less.
