All that piece, parcel or lot of land in Butler- - - - -Township, Greenville County, State  
of South Carolina. near the Butler Springs Road, containing four (4) acres, and  
described as follows:

BEGINNING at an iron pin at corner of other property of Dillwyn Parrish, and running thence with the line of his property, N. 12-25 E. 238.8 feet to an iron pin; thence N. 38-00 E. 466 feet to an iron pin; thence N. 75-00 W. 221 feet to a stake in line of other property of Gertrude Hudson Waldrop; thence with her line, S. 40-49 W. 737.9 feet to a stake in line of other property of Dillwyn Parrish; thence with his line, S. 74-30 E. 371 feet to an iron pin. Being the same property conveyed to the grantor by Gertrude Hudson Waldrop by deed dated June 2nd, 1947, and recorded in the Office of R.M.C. for Greenville County in Book 313 at Page 176.

BEGINNING at an iron pin in road, and running thence N. 61 00 W. 273.3 feet to iron pin at bend in Road; thence N. 82 30 W. 247.5 feet to an iron pin at bend in road; thence N 74 45 W. 242.8 feet to an iron pin at bend in Road; thence S 88 30 W. 99.6 feet to an iron pin, Ed Henderson's corner; thence N 19 15 E 217.8 feet to an iron pin; thence S 74 30 E 532.5 feet to an iron pin; thence N 12 25 E 238.8 feet to stone and iron pin; thence N 38 00 E 942.6 ft. to an iron pin (Chestnut Oak); thence S 17 06 W 152.8 feet to an iron pin at bend in road; thence S 6 28 W 241.0 feet to an iron pin at bend in road; thence S 3 20 W 254.0 feet to an iron pin at bend in road; thence S 15 00 W 139.8 feet to an iron pin, center of road, corner of Leonard Green; thence S 30 13 W 556.0 feet to an iron pin at the beginning corner, containing 10.25 acres, more or less.
