

S. C.KNOW ALL MEN BY THESE PRESENTS, That HOMES, INC. OF GREENVILLE, S.C.a corporation chartered under the laws of the State of South Carolina

and having its principal place of business at

Greenville in the State of South Carolinafor and in consideration of the sum of Eight Hundred Eighty Nine and 41/100 Dollars,(\$89.41) and assumption of mortgage referred to belowto it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release untoDON C. JONES AND EMMA W. JONES, Their Heirs and Assigns, Howey, Fla.

All that piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being in Chick Springs, Township, County of Greenville, State of South Carolina, and being known and designated as Lot No. 116 according to a plot of Super Highway Home Sites prepared by Dalton & Neves, Engineers, May, 1946, which plot is recorded in the R. M. C. Office for Greenville County in Plot Book 7, at page 53, and restrictions as recorded at same place in Deed Book 291, pages 362 and 372 and having the following notes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Broad Vista Boulevard at the joint front corner of Lots # 115 and 116 and running thence along Eastern side of Broad Vista Boulevard, N. 4-42 W. 80 feet to an iron pin at joint front corner of Lots # 116 and 117; thence along common line of said last mentioned lots, N. 12 C. W. 194.8 feet to an iron pin at joint rear corner of Lots # 116 and 117, also being the center of a five foot strip reserved for utilities; thence along rear of said utilities strip, S. 2-00 W. 110 feet to an iron pin at joint rear corner of Lots # 116 and 115; thence along the common line of said lots to the joint front corner, N. 12 C. W. 132.7 feet to an iron pin, the beginning corner.

This being part of the same property conveyed to the grantee herein by W. C. Green Jr. K. Taylor and R. K. Taylor, Jr. dated July 31, 1947, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 318, at page 322.

Also conveyed is one 30 Gallon Automatic Electric Hot Water Heater for use at the dwelling on the above described property.

As a part of the consideration for this conveyance, the grantee agrees and agrees to pay the balance due on that certain mortgage given by the grantee to the Residential Insurance Company of America, occurring the sum of \$1,000.00, dated April 25, 1947, and recorded in the R. M. C. Office for Greenville County.
