Beginning at an iron pin on the southern edge of a five (5) foot sidewalk running along Berkley Avenue, said pin being the joint front corner of lots numbered twenty-one (21) and twenty-two (22); and running thence along the southern edge of said sidewalk, S. 80-52 £., sixty (60) feet, to an iron pin, joint front corner of lots twenty (20) and twenty-one (21); thence along the western line of lot twenty (20), S. 9-08 W., one hundred and thirty-four and four tenths (134.4) feet to an iron pin, joint rear corner of lots twenty (20) and twenty-one (21); thence along the rear line of lot twenty-seven (27), N. 80-03 W., sixty (60) feet, to an iron pin, joint rear corner of lots twenty-one (21) and twenty-two (22); thence along the eatern line of lot twenty-two (22), N. 9-08 £., one hundred and thirty four and four tenths (134.4) feet to an iron pin, the beginning corner, said lot being known and designated as lot numbered twenty-one (21) on Plat of said property recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book "R" at page 127, which plat is hereby referred to and made a part hereof.

Said property is in a restricted district, and is sold subject to the following restrictions, which constitute a part of the consideration therefor, and shall be effective for a period of twenty-five (25) years from the date hereof:-
