


to the grantor(s) in hand paid at and before the scaling of these presents by the grantee(s) (the receipt whereof is hereby action knowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John C. Inglis and Verna A. Inglis, their heirs and assigns, forever:

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being on the East side of Parkwood Drive in that area recently annexed to the city of Greenville in Greenville County, S. C., being shown as Lot 56 and a portion of Lot 55 on plat of Northwood made by Dalton & Neves, Engineers, June 1939, recorded in the R. M. C. office for Greenville County, South Carolina, in Plat Book "J", pages 102 and 103, and having, according to said plat and a recent survey made by A. C. Crouch, Engineer, August 7, 1948, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Parkwood Drive in the front line of Lot 55, said pin being 115 feet north from the Northeast corner of the intersection of Parkwood Drive and WoodbineRoad, and running thence with the East side of Parkwood Drive, N. 19-30 E. 105 feet to an iron pin at front corner of Lot 57; thence with the line of Lot 57, S. 73-28 E. 151.4 feet to an iron pin; thence S. 37-0 W. 38 feet to an iron pin; thence S. 2-0 E. 30 feet to an iron pin; thence S. 17-45 W. 29 feet to an iron pin; thence N. 77-32 W. 152.2 feet to an iron pin on the East side of Parkwood Drive, the beginning corner.

Being all of Lot 56 above described conveyed to the Grantors herein by deed of P. R. Long dated Oct. 9, 1941, recorded in R.M.C.Office for Greenville County, S. C. in Deed Book 238, page 117; and the greater portion of Lot 55 by deed of W. M. Bishop dated May 23, 1944, recorded in R.M.C.Office for Greenville County, S. C. in Deed Book 264, page 55.
